Select Board Report March-September

Anyone who has spent time in Belgrade can see that the backbone of our town is its volunteers. Yes, we have a super town manager and excellent staff, but our volunteers set the town's wheels in motion. From the Food Pantry in North Belgrade, to the library in the Depot, to the annual Bean Hole Supper at the Center for All Seasons, volunteers make things happen all around town.

Ad Hoc Public Works Committee

One of the best examples of volunteer effort is the town's recent need to determine who will clear the roads of ice and snow beginning a year from now. Our current winter maintenance contractors, the Warren Brothers, out of Smithfield, informed the town that they will be retiring at the close of the 2023-24 winter season. Knowing how hard it can be to find a contractor to take over the plowing and sanding of Belgrade's 48 miles of town roads, the Select Board authorized Town Manager Lorna Dee Nichols to form an ad hoc committee to explore the options: find a private contractor (or contractors) to assume the job, share services with a neighboring town, or establish a town public works department, which would require securing a facility, equipment and personnel.

The committee was charged with exploring all options simultaneously because of the lead time required to set up our own operation.

Eleven Belgrade residents came forward to serve on the ad hoc committee: Craig Alexander, Keith Alexander, Carl Cooke, Michael Harrington, Kevin Hawes, Sara Languet, Gary Mahler, Penny Morrell, John Skinner, David Stevens and Tom Streznewski Jr., who was named chair. Joining them were Road Commissioner Jason Stevens, Facilities and Grounds Director Cory Alexander, Transfer Station Director Ken Scheno, and Selectperson Carol Johnson.

The committee was divided into subgroups to contact plowing contractors, look into possible sites and equipment that would be needed for a PW department, and explore personnel needs. Meetings were held from March through June, often weekly, to share ideas and information. In the end, the committee's persistence paid off—they identified a private contractor from Sidney who was awarded a three-year contract by the Select Board in July. Brook Cummings and his sons will work with Warren Brothers this winter to familiarize themselves with the routes. With their mission complete,

the Select Board expressed its deep gratitude and dissolved the Ad Hoc Public Works Committee in July. Special thanks to Jack Sutton, who kept reminding the Select Board to address this matter and to Lorna for keeping the committee on task.

Comprehensive Plan Committee

A major volunteer effort underway this fall is the update to the Comprehensive Plan. Every 10 years, the town updates its comprehensive plan with assistance from Kennebec Valley Council of Governments.

The plan was last updated in 2013 and approved by voters in June 2014. More than 50 residents and staff served on the overall committee and the subcommittees that developed recommendations for the future direction of the town, in such areas as recreation, natural resources, housing, and growth and development.

The 2014 plan states:

A Comprehensive Plan is not a state mandate. It is a community imperative. To know where we are going as a community and as a culture is the only way in which we can preserve what we love and change things that interfere with getting where we want to go. A Comprehensive Plan is one of those rare opportunities to come together and make decisions about our future together. It's a chance to make a better life for generations to come. It is a basic part of democracy, our right to debate and find the path that demands the best from everyone.

The committee, chaired by Anthony Wilson, met in September with KVCOG to begin the process of organizing the update, which will include forming subcommittees, developing surveys, timelines, etc. As in 2013, we will need a lot of help, so please contact the town office if you are interested in joining the effort.

March Town Election Results

The Select Board welcomed new member Peter Rushton, formerly chair of the Planning Board, who was elected March 17 to a two-year term, filling the seat held by the late Rick Damren. Dan Newman was re-elected to another term as selectperson.

ARPA Funding

The town has received \$332,777 in American Rescue Plan Act funding from the federal government to use for special projects.

To date the Select Board has allocated \$162,250 as follows:

- \$30,000 to 7 Lakes Alliance for erosion control projects on town properties on Great Pond and Long Pond
- \$28,000 for the Comprehensive Plan update through KVCOG
- \$10,000 for grub treatment at the cemeteries and the town office
- \$48,000 for repairs to the dam in Belgrade Lakes Village
- \$46,250 to CAI to digitize the town's tax maps.

The board expects to allocate the remaining balance of \$170,527 by the end of the year.

Policies

The board approved a new Acceptable Use Agreement for computer use and cyber security and made updates to the Employee Handbook, which is an ongoing project.

Volunteer Opportunities

The Select Board invites town residents to get involved in the common purpose of helping Belgrade become the best town it can be. You can make a difference by joining a town committee or board. Meetings are generally held monthly to review activities with the appropriate department head and bring recommendations to the Select Board, within the goals of the Comprehensive Plan.

Town Board, Committee Vacancies

There are 18 openings on town boards and committees. Surely there's one that interests you. It's a great way to get involved!

Appeals Board: The board hears and decides appeals by residents who believe there's been an error in a decision made by the code enforcement officer or planning board. 2 alternates needed.

Assessment Review Board: The board hears and decides property tax abatement appeals that are refused by municipal officers or assessors. 2 alternates needed.

Board of Parks and Recreation: The board advises and makes recommendations to the recreation director on town recreational activities. 2 members, 2 alternates needed.

Comprehensive Plan Committee: (See description in Select Board Report). 2 openings.

Lakes and Natural Resources Committee: The committee researches, documents, and promotes the conservation of Belgrade's natural resources, including lakes, streams, wetlands, and groundwater, as well as forests, wildlife, fish and aquatic habitat, intact shoreland, and scenic areas. 3 openings.

Library Board of Trustees: The board advises the town manager and Select Board on library operations policies. 1 opening.

Roads Committee: The committee advises the road commissioner and Select Board on matters related to the town's roads and their maintenance. 1 opening.

Transfer Station Committee: The committee advises the Select Board on matters related to operation and maintenance of Transfer Station and Recycling Center. 1 opening.

Water District Trustees: The board oversees the operation of the Belgrade Water District. 2 openings.

Town Manager's Report

It's been my great pleasure to get to know many of you and learn the rich history of the town of Belgrade during my first year as your town manager. Thanks to a hard-working staff and dedicated committee members, we strive to provide the best municipal services to residents and visitors alike. I have an open door policy and welcome your visits to discuss any concerns and ideas you may have to strengthen our community.

Budget Season Underway

The 2024 budget season is now underway. Department heads are developing their budget proposals for review by the Budget Committee beginning this month and by the Select Board beginning in November.

Voters will act on the 2024 budget at Town Meeting in March.

New Town Office Hours

With approval from the Select Board, the Town Office will move to a four-day work week, effective Dec. 1. This is being done on a trial basis of four 10-hour days.

The new schedule will be 7 a.m. to 5 p.m. Monday, Tuesday and Friday; 7 a.m. to 7 p.m. on Thursday. The office will be closed on Wednesday.

Water System Update

Slow but steady progress is being made on the creation of the water system to serve the area bounded by Routes 27, 8/11 and 135. The state Department of Transportation is doing ledge borings for the new well site, which began in late September. Once those are complete, surveyors will confirm elevations along the run so that plan and profile drawings can be completed.

The state will coordinate with individual property owners to complete the services.

Browntail Moth Mitigation

The town has secured funding from a state grant for browntail moth mitigation in town, which will begin April 2024. This may not remove the nuisance completely, but should dramatically decrease the population for the 2024 summer season in these areas. Information is available on the health section of the town website.

Cyber Security, Computers

Federal funding for cyber security and computer upgrades may be available and administered through the state to enable the town to upgrade several computers in municipal buildings. The town is closely monitoring the program for funding to improve cyber security instead of adding the costs into the 2024 budget.

Public Safety Communications

Public Safety Answering Point services for fire and rescue were in jeopardy when Somerset County dropped 16 Kennebec County towns, including Belgrade. Through some quick legislative work and help from the state, Waterville has contractually agreed to cover Belgrade for this important dispatch service.

November Election

Polls will be open 8 a.m. to 8 p.m. Tuesday, Nov. 7, at the Center for All Seasons, 1 Center Drive, for the state referendum election.

Absentee ballots will be available beginning Friday, Oct. 6. Absentee voting will end on Thursday, Nov. 2. To get an absentee ballot mailed to your home, call the town office at 207-495-2258, or request one through the secretary of state website. Visit the town website for a link. You may also visit the Town Office to vote absentee during regular office hours.

Nov. 7 Referendum Questions

QUESTION 1: An Act to Require Voter Approval of Certain Borrowing by Government-controlled Entities and Utilities and to Provide Voters More Information Regarding That Borrowing. Do you want to bar some quasi-governmental entities and all consumer-owned electric utilities from taking on more than \$1 billion in debt unless they get statewide voter approval?

QUESTION 2: An Act to Prohibit Campaign Spending by Foreign Governments and Promote an Anticorruption Amendment to the United States Constitution. Do you want to ban foreign governments and entities that they own, control, or influence from making campaign contributions or financing communications for or against candidates or ballot questions?

QUESTION 3: An Act to Create the Pine Tree Power Company, a Nonprofit Customer-owned Utility. Do you want to create a new power company governed by an elected board to acquire and operate existing for-profit electricity transmission and distribution facilities in Maine?

QUESTION 4: An Act Regarding Automotive Right to Repair. Do you want to require vehicle manufacturers to standardize on-board diagnostic systems and provide remote access to those systems and mechanical data to owners and independent repair facilities?

QUESTION 5: RESOLUTION, Proposing an Amendment to the Constitution of Maine Regarding the Timing of Judicial Review of the Determination of the Validity of Written Petitions. Do you favor amending the Constitution of Maine to change the time period for judicial review of the validity of written petitions from within 100 days from the date of filing to within 100 business days from the date of filing of a written petition in the office of the Secretary of State, with an exception for petitions filed within 30 calendar days before or after a general election?

QUESTION 6: RESOLUTION, Proposing an Amendment to the Constitution of Maine to Require All Provisions in the Constitution to Be Included in the Official Printing. Do you favor amending the Constitution of Maine to require that all of the provisions of the Constitution be included in the official printed copies of the Constitution prepared by the Secretary of State?

QUESTION 7: RESOLUTION, Proposing an Amendment to the Constitution of Maine to Align the Proceedings for Circulating Written Petitions for Peoplen's Vetoes and Direct Initiatives with Federal Law. Do you favor amending the Constitution of Maine to remove a provision requiring a circulator of a citizen's initiative or people's veto petition to be a resident of Maine and a registered voter in Maine, requirements that have been ruled unconstitutional in federal court?

QUESTION 8: RESOLUTION, Proposing an Amendment to the Constitution of Maine to Allow Persons Under Guardianship for Mental Illness to Be Electors. Do you favor amending the Constitution of Maine to remove a provision prohibiting a person under guardianship for reasons of mental illness from voting for Governor, Senators and Representatives, which the United States District Court for the District of Maine found violates the United States Constitution and federal law?

Dog Registration Deadline

It's dog registration time again! Please bring the most recent rabies vaccine certificate to the town office when you register your dog. If you are registering a new dog, bring proof of the dog being spayed or neutered.

Registration fee is \$6 for dogs that have been spayed or neutered, \$11 for those that have not been.

Dog tags will be available beginning Oct. 16. Re-registration may be done online. Visit the town website town clerk page for a link.

If your dog is deceased please, contact the Town Office so it can be removed from the records.

Dog owners who register by Dec. 31 will be included in a drawing for a dog gift basket of treats and toys.

Rabies Clinic

The town will hold a rabies clinic from 9 a.m. to 1 p.m., Saturday, Oct. 21, at North Belgrade Community Center, 508 Smithfield Road. Call the Town Office for a signup time.

Dog owners can also register their dogs at the clinic. Dogs must be on a leash. The rabies shots are free for town residents; \$10 for nonresidents.

Bring a previous rabies certificate or tag for a three-year registration. A one-year vaccination will be given to dogs without previous rabies information.

This summer we saw bigger numbers at both our concerts and our craft fairs. Pat Colwell and the Soul Sensations brought more than 400 people to the Village Green! The bands certainly appreciated the attendance this year, we already have musicians asking to come back.

The craft fair vendors had the same message. They loved the attendance at the monthly craft fairs on the Village Green. Many said, "We love this event, the people here are just so nice." As the one who coordinates these events, it is nice to have positive feedback from both sides.

Cemetery Committee

The Cemetery Committee wants to make sure everyone knows the procedure for requesting a cemetery lot.

Anyone requesting a cemetery lot must speak with the sexton, who can be contacted through the Town Office.

People who are not residents of Belgrade must:

- Have a birth parent or legal relative who resided in the town at the time of their birth.
- Have relatives either living in Belgrade or buried in the cemetery.
- Must own and have paid property taxes or real estate in the town for at least 20 years.

After contacting the sexton, you will be directed as to how to complete the process. The sexton can be reached through the Belgrade Town Office.

The cemetery sexton requests that all summer decorations be removed by Nov. 15.

Belgrade Public Library

The library has wrapped up a successful summer of events and programs, and is planning fall and winter programming.

With visits to the library on the rise, it feels like recovery from the COVID-19 shutdowns has finally happened.

This year's Belgrade Community Read, "This Wild Land," by Andrew Vietze, was a big success, culminating in an author talk by Vietze on Aug. 24.

Adult programs this summer also included an author talk by mystery writer Paul Doiron, whose latest book, "Dead Man's Wake," is set in Belgrade. The event, organized by trustees Chair Maureen Milliken and Renee Cunningham, Oliver & Friends Bookshop owner, was truly a town-wide partnership, with a big assist from Dan MacGlashing, parks and recreation director, who helped with the venue planning and setup. Dianne Dowd, trustees vice-chair, organized the catered food, which was made possible by a donation from Liz Fontaine, of Lake-Home Real Estate Group.

Doiron's visit drew more than 200 fans and book lovers to the Community Center for All Seasons on June 29.

Other programs this summer were "Fatal Footsteps: Katahdin's Lost Hikers," a slide program by Milliken designed to complement the community read; author Tim O'Brien, "Maine Roadshow," and author Gary Hoyle, "Mystery Tusk," which was held in partnership with the Belgrade Historical Society. Eric Hoogland also gave a talk about "The Belgrade Lakes Region," his newly published Images of America book

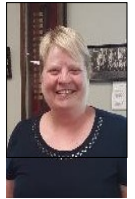

Belgrade Regional Health Center Board Sponsoring Free Flu Shots

Belgrade Regional Health Center Board of Directors is sponsoring a free flu shot clinic from 8 a.m. to noon, Saturday, Oct. 7.

The event, staffed by the health center's clinical team, is open to the public.

It's just one of many community events the board sponsors aimed at health and wellness.

Belgrade Regional Health Center, founded in 1977, is a part of HealthReach Community Health Centers, a federally qualified health center with headquarters in Waterville. BRHC is one of 12 HealthReach community health centers in central and western Maine.

The BRHC Board of Directors is made up of community members, and oversees the health center building. The board is involved in — and supportive of — the health center's mission. The two work together on events for the Belgrade community to provide healthy living options that serve patients and the public.

The board sponsors movement classes at Dockside physical therapy and the Center for All Seasons for health center patients. The board also encourages the public to use the quarter-mile long walking trail that begins at ends at the parking lot of the health center.

Dams Committee

Greetings from the Belgrade Inter-lakes Dams Committee

As I write this, all of our ponds are in great shape, all right at full pond. Hurricane/Tropical Storm Lee could have caused issues, so we dropped levels down five inches to make room for the incoming storm. That is considered adequate, but there were still a lot of boats that needed to move around, so we didn't want to drop the levels too far.

While the emergency is over, and we came out OK, it's worthwhile to remember that in situations like that storm, there is no winning. Just prepare as best you can with the information that you have.

Overall, everything is good for this time of year despite the incessant rain of earlier. This fall, we will actually have to let water out to achieve our fall lake drawdown mandated levels. Remember four short years ago, Long Pond was already down 24 inches at this time.

Our 2023-24 fall lake drawdown mandate calls for Great and Long ponds to be drawn down to 1.5 feet to 2 feet, and Salmon down to 1 foot to 1.5 feet by Nov. 1. Weather permitting, the drawdowns will begin after Indigenous People's Day weekend, and we are looking forward to another slow and regulated process.

Our fall project this year is rebuilding our Great Pond Village dam, where the concrete has severely deteriorated. We are expecting to have the project completed by Nov. 1. We will incorporate a cofferdam to hold Great Pond back during the two-week project so we don't lose any more water than necessary.

Thank you all for your continued support and enjoy your fall! Let's hope it's beautiful.
